## Appendix .JE of the Agreement

This appendix only concerns the registration and administration of domain names with the ending .JE (second-level and third-level domains).

.JE is the 2-Letter ISO Country Code of Jersey.

#### **Preliminary Remark:**

Key-Sytems GmbH through 1API GmbH is an officially ICANN accredited and authorized registrar of Island Networks Ltd. for the domain extension .JE.

RSP and KS agree that RSP can register, renew and administer domain names beneath .JE, .CO.JE , .NET.JE , .ORG. JE for his customers through KS.

The following paragraphs apply:

### § 1. Registration Requirements

All accredited registrars and resellers of .JE second-level and third-level domain names are committed to these terms and conditions. Each customer who registers a domain name beneath a .JE domain extension has to accept the following terms and conditions. RSP is committed to bind his customers according to these regulations.

As the registry does not publish registrant contact details in the WHOIS, such services are deemed unnecessary. The registry reserves the right to deactivate or cancel any domains using such services after July 23. Please make such you check and if necessary update any affected domain names.

RSP will ensure through it's Registration Agreement that the registrants acknowledge and agree to that once the Agreement with the registrant has come to an end, it is expected that the domain name will be deleted. Once a domain name is deleted, the registry will contact the former registrant with an

opportunity to recover their domain name by giving them, for a short time, priority in reregistration.

The domain name shall not be to a third party, or to RSP, instead of deleting it. RSP is obliged to enforce this regulation.

The registration or renewal of a registration is possible for a period of 1-2 years.

### § 4. Costs

The prices of a registration and included services can be viewed directly through the web interface under the respective top-level domain.

All costs will be charged in USD, meaning that when registering a domain KS will automatically exchange the respective fee into USD according to the daily exchange rate of the European Central Bank (ECB).

V.A.T. only applies to RSPs who have their corporate office in Germany or to RSPs within the European Union, who do not possess a valid V.A.T. ID. V.A.T. Is not applicable to RSPs outside the European Union.
